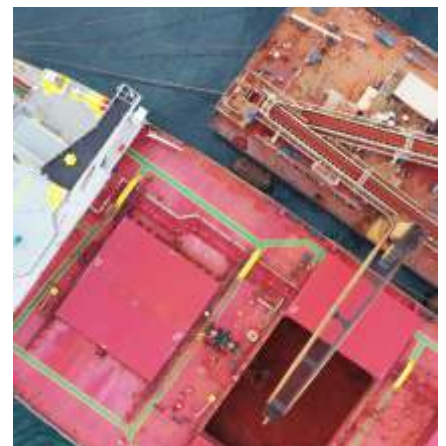

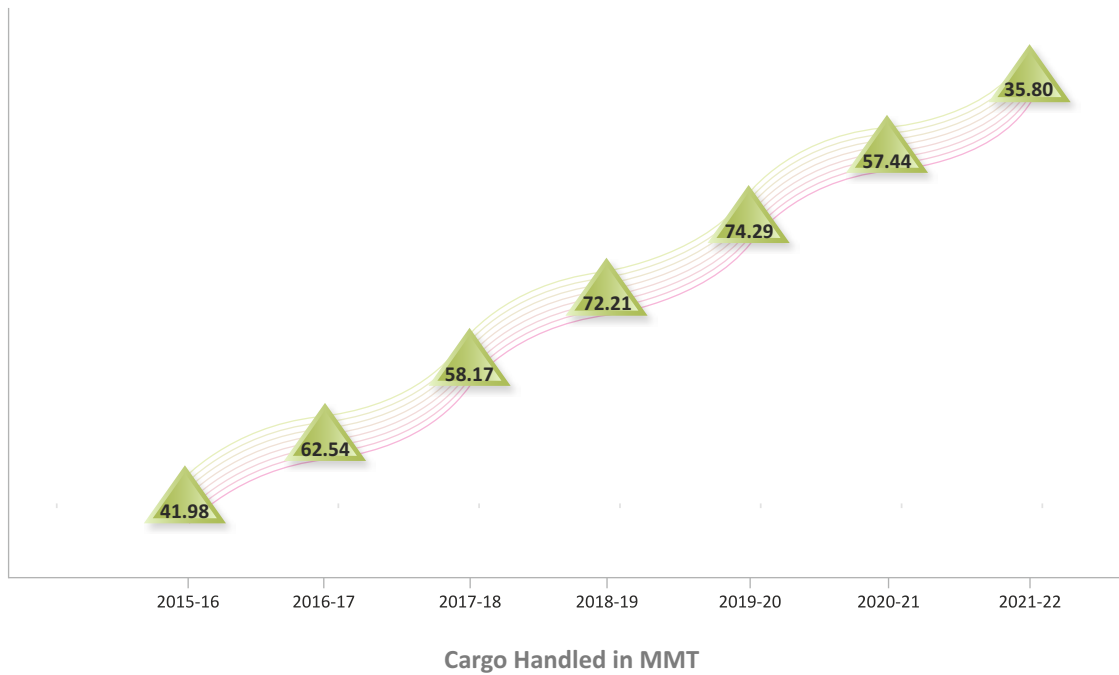




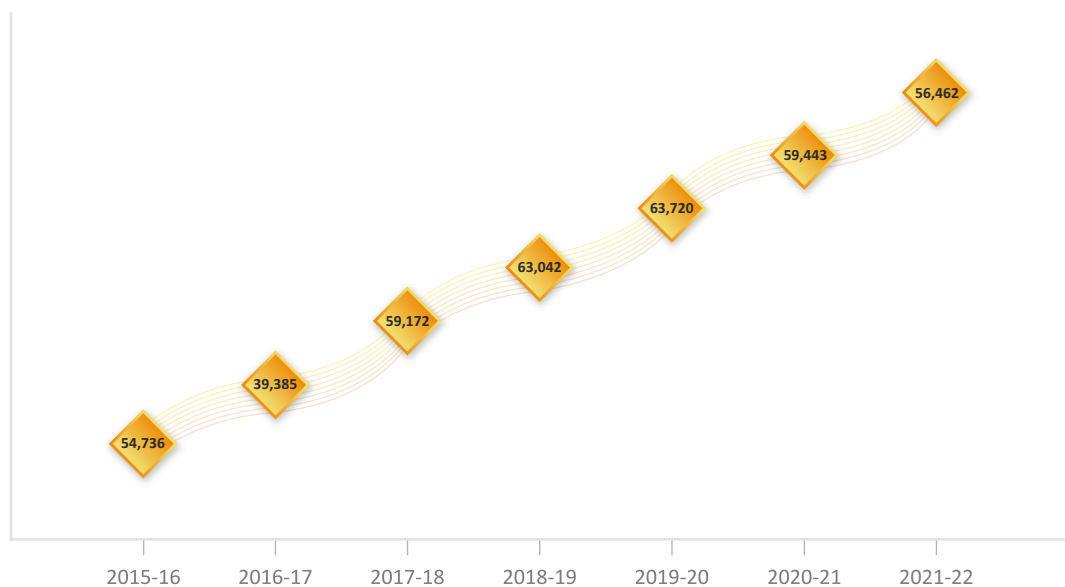

## STEVEDORING BULK



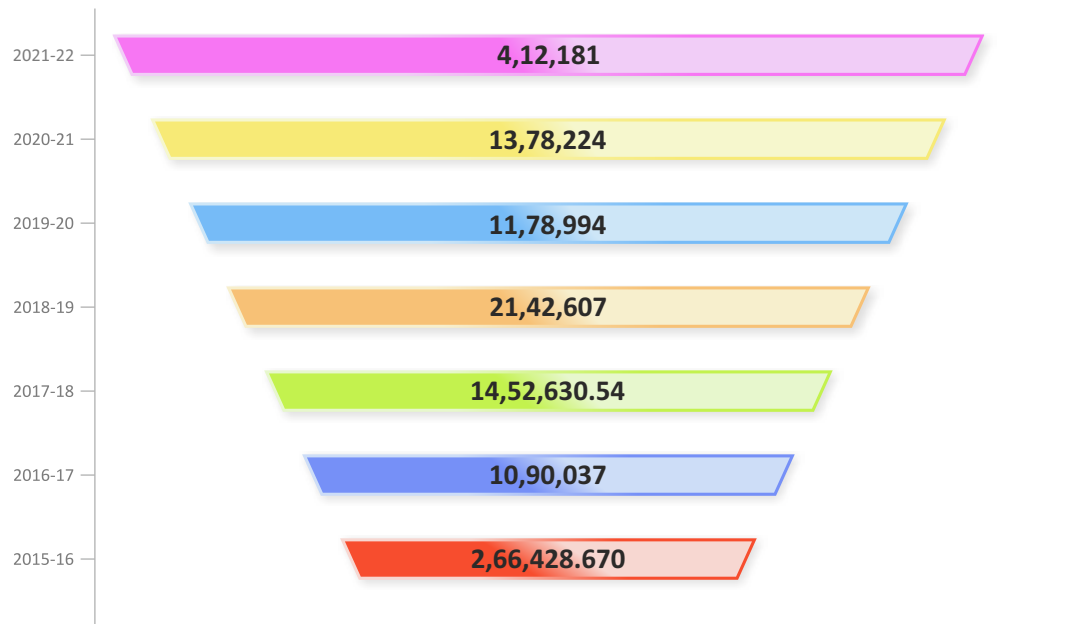
## STEVEDORING CONTAINERS (TEUs)



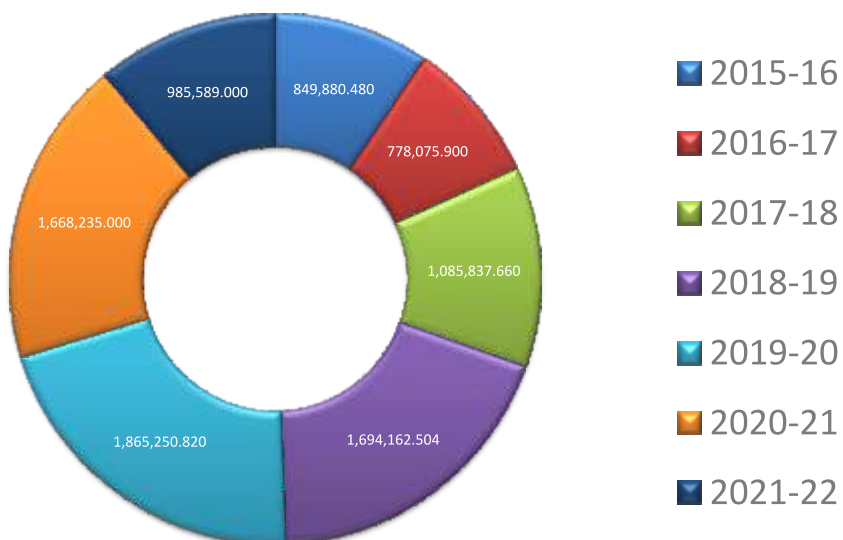
